I am requesting funding for Membrane Softening Drinking Water Upgrades in fiscal year 2023.

The entity to receive funding for this project is the City of Hollywood, Florida, located at 2600 Hollywood Boulevard, Hollywood, FL 33020.

The funding would be used to provide clean, safe, and reliable potable water service for thousands of residents in Broward County, Florida. The City of Hollywood would use these funds to replace all seven Membrane Softening trains at the water treatment plant, which are past their useful life. These Membrane Softening trains operate at a capacity of two million gallons per day. The existing membranes will be replaced with a newer and more advanced two-stage membrane softening system that is more energy efficient and reliable than the existing system. In addition to the replacement program, electronic operations and cyber security will also be enhanced. This project serves an essential need of the residents and businesses to have potable drinking water.
